Update to be provided for next meeting.</li> <li>• Housing providers having difficulties with managing repairs and maintenance – rent increases being flagged but maintenance is slow. Bhill and Wentworth not eligible for same benefits as rest of MP Region. Housing issues outside of remote classification with other individual issues such as tenancy management, overcrowding and rent increases. Boomali Consulting were refused access to the standards during the compilation of the MP Regional Plan.</li> <li>• AEC interested in discussing further the amnesty proposed to encourage more Aboriginal participation in voting across three levels of government. LG elections had Aboriginal candidates across MP region and an additional 36 people registered to vote as well as Aboriginal people volunteering to assist in election.</li> <li>• CPO's not clear about their participation in the development of Community Action Plans (CAPS). Some of the more experienced participants are ready to start mentoring. Public speaking, motivational workshops, self development, career development with Unis and TAFE, governance. Homelessness, health and unemployment. A new Strategic Plan and Operational Plan to be developed by the Advisory Council. Website to be developed and will include a chat room for communication. More engagement between CWP's and the Advisory Council on a more regular basis than just the 4 Assembly meetings. Activities in local communities and this to include CWP Chairs where possible. Thanks from Steve Butler for support from CWP Chairs during his time as Acting Director. CPO's still working with CWP's but also to be utilised for community projects, to be determined. Ivanhoe will come under Broken Hill because of the placement of staff. Position is being advertised currently. From each of 3 offices BHILL will be under Ivanhoe, Broken Hill, Menindee. Cobar will service Bourke, Brewarrina. Will CPO's be able to spend more time in communities. Lead CPO's but other staff will be able to assist where necessary. CWP Chairs have not as yet been involved in the changes.</p> <p>Ministerial Taskforce consultations have occurred – 38 attended Cobar. The process to finalise the CAPs will continue to be supported by CPO's. Bringing relevant agencies into the mix will occur once Plans are completed and actions identified. Plans to be completed in a realistic timeframe, looks like 3-6 meetings. Unexpended funds may be able to be spent on those meetings.</p> <p>Bourke office to be occupied by AANSW and DET but office for MPRA not connected to IT or phone.</p> <p>Proposals to have duplicate structures from government are opposed by the Regional Assembly. The Assembly is a model that is community driven and is supported across the region by the majority of people in our communities. Functions should not to be duplicated without argument. Mark Conlon to discuss tomorrow. Regional Plan is a Strategic document – action plan to be developed by government. Not possible for government funded programs to make complaints about other government programs that have failed. Important to remember the longevity of the Assembly, its successes and usefulness for Aboriginal people. The Assembly has gained recognition for its work and it should be remembered that some of the dissident people who are looking for alternative models have been excluded because of past behaviours and it should be taken on board.</p> <p>NGO forum is to focus on NGO agencies, service delivery and government requirements and where the Regional Assembly. The benefits for NGO's in using the Assembly for advice, information and how to go about engaging with communities can also benefit local communities. Readiness of NGO's to manage funds is another opportunity that comes from that engagement. <ol style="list-style-type: none"> <li>1. <b>Mark Conlon AANSW – Apologies from Jason</b>              Steve Butler has been appointed as a Project Officer to drive RPA with some support staff. Important to have a monitoring and evaluation framework to measure successes of the Assembly. Early to mid November for draft document to review.</li> <li>2. Assembly would like the Minister/Dept to include anything that they particularly want in a draft to clarify their intention. Minister is interested in what the Assembly particularly wants. That will enable government to line up the common ground with the Assembly. The Plan is to be viewed as a Regional Strategic Plan. The Action Plan is to be developed by government in response.</li> <li>3. Taskforce report back – Education, Employment and Economic Development are the 3 Terms of Reference for the Taskforce. The Progress Report is a document to say these 3 things are the focus for us at the moment.</li> <li>4. Opportunity hubs – development from training to employment opportunity dedicated to identifying pathways to employment</li> <li>5. Language lighthouses – bring language and culture into education for Aboriginal children. Establish Centres for language development and growth</li> <li>6. Local Decision making – to address service delivery shortfall. Three stage process to be trialled in 3 locations and is currently viewed as a concept which can be opposed if desired. Map current services and priorities, dpac person allocated who can direct priorities once identified by community,</li> <li>7. Assembly does not make decisions about service delivery currently. What funding is involved in this process is it current health, education, police funding or is it the ad hoc supplementary funding that is allocated?</li> <li>8. CMA legislation has been identified as 'model' legislation because it is enabling legislation which does not proscribe capacity of communities to make determinations for and on behalf of communities.</li> <li>9. Concerns about how this policy will impact on current structures and that accountability is already high in Aboriginal services but not so in government service delivery.</li> <li>10. Discussion between Assembly delegates and AANSW regarding concerns about how the Policy shift may impact on community. Only State Govt – not inclusive of local or federal govt. James Christian, State Manager FaHCSIA and Leonard Hill, Manager Dubbo ICC</b> Regional Partnership Agreement- Federal Govt committed to pursuing Agreements particularly the Murdi Paaki Agreement. Minister Macklin committed to seeing progress. Potential of freeing up a position for Executive support for MPRA if funding can't be secured. NSW Govt looking for comment from Land Councils regarding governance structures. Most CWP members and Assembly members are also Land Council members. Coonamble CWP and Lanc Council are discussing MOU with a view to developing improved relationships. NSWALC Chair is also a member of MP Assembly and participated regularly until his appointment limited his available time.</p> <p>Regional Plan has been well received and need to make the implementation occur, perhaps by having key senior government people to discuss the Plan.</p> <p>Remote Jobs Community program- current system has lots of training, few jobs and current agencies aren't working well in remote areas. EOI for Tenders has also been delayed due to some restructuring. Joint information sessions to be undertaken with DEWAR. Single provider for disabilities, job support. Issues for Gulargambone, Coonamble, Collarenebri, Walgett, Ivanhoe – there are 8 areas in Murdi Paaki that are excluded. There are 50 jobs that will be lost by the introduction of this system. Risk management plans to be constructed because loss of jobs is not the aim. Income to areas remains the same or greater, through the EOI process current CDEP providers get sufficient support to participate in EOI process. CDEP providers grandfathered for 3 years nationally for 1670 participants. IEP will be available in non remote jobs areas. Comm Dev fund will be available in remote jobs areas. Youth participation will be funded. IEP will be available for young leaders program. Collarenebri is outside RJCP area and need to know what JSA's are doing in places like Collarenebri. CDEP program around harvesting which needs to be investigated and perhaps developed. No CDEP post June 30 2013. 16 hours work will be a requirement for CDEP participants after that time. Transition funds to be provided for those communities excluded from RJCP and clear plan required.</p> <p>Orana Haven having difficulty securing funds after end of year. There is a demonstrated need for service – no planning or staff recruitment. Unable to continue to take referrals although there is a constant requirement for the support service. Breaking the Cycle has commenced in Bourke and Brewarrina.
